7. Summary of Etisalat Group's performance for the last fiscal year

Etisalat Group's financial performance during the year ended 31 December 2017 is summarized in the financial metrics below:

- The consolidated revenue for Etisalat Group for fiscal year 2017 amounted to AED 51.7 billion, representing a year on year decline of 1.33% (AED 0.7 billion). This is mainly attributed to the impact of unfavorable exchange rate movements in Egyptian pound against AED. Etisalat UAE revenue increased year on year by 2.8% as a result of growth in the subscriber base in the mobile postpaid and eLife segments, higher demand for mobile and fixed data services, and increased offering of business solutions, digital and ICT services.
- Etisalat Group consolidated profit attributable to the equity holders of the Company amounted to AED 8.44 billion, exhibiting an increase of AED 0.02 billion in comparison to the corresponding period in the prior year.
