7. Summary of e&'s performance for the last fiscal year:

e&'s financial performance during the year ended 31 December 2022 is summarized in the financial metrics below:

- The consolidated revenue for e& for fiscal year 2022 amounted to AED 52.4 billion, representing a year on year decrease of 1.7% (AED 0.9 billion). impacted by foreign exchange rate volatility in our international markets putting pressure on reported currency in AED. However, in constant currencies, e& delivered strong operational and financial performance leading to an increase in revenue by 4.7%.
- e& consolidated profit attributable to the owners of the Company amounted to AED 10 billion, representing a year on year increase of 7.4% (AED 0.7 billion).
