- 1. Candidacy for Etisalat's Board Directorship will remain open for (10) days from the date of the respective announcement pursuant to the requirements of Article (9) of SCA's Resolution No. (3/Chairman) of 2020 concerning the Approval on Public Joint Stock Companies Guide and its amendments ("Governance Guide").
- 2. A candidate for directorship must satisfy the conditions set forth in the Federal decree by Law No (32) of 2021 concerning Commercial Companies and the Governance Guide.
- 3. A Candidate's application should enclose the documents referred to in Article (10) of Governance Guide.
- 4. After closure of candidacy, no candidate may assign his candidature to the favor of any other candidate.
- 5. Etisalat will post the names of the candidates and their candidacy details on the bulletin boards located in its Head office and on its internet website https://eand.com on 08/04/2024.
- 6. After closure of candidacy, a list comprising the names of candidates will be provided to SCA.
